We are driving for better educational and employment opportunities for girls and women, including through the increased use of local community facilities, as well as measures to continue to increase women's community leadership.

The aspirations and actions set in motion this year will influence generations to come. We know this well and strive to achieve the maximum impact with the resources entrusted to us. We invest in evaluating our work so that we can continue to learn from what we do and to improve further. As this report underscores, BWA Limited strongly committed to delivering well-targeted programmes, and enlisting game-changing partners to accelerate the pace of change. Together we can usher in a new era that is more just, resilient, and inclusive of all.



Executive Summary

Bangladeshi Women's Association Limited

At BWA Limited we are committed to creating social capital and social change through delivering community led regeneration, giving the residents of Tipton free access to advice information and training whilst providing local venues for all communities to get more connected, empowered and confident to have a real stake in the development of the area. Over the past thirty two-year BWA has developed into a community organisation of standing, providing a holistic and integrated package of community services to meet the needs of diverse residents in Tipton. Supported by a number of funders and partners BWA currently has 19 active projects related to health, education, employment, skills, and social



inclusion. According to BWA client monitoring data, the organisation annually provides direct services to an average 2500 residents, deals with 3400 queries and increases household income by an average of £300,000 annually.

In the delivery of community services BWA has adopted a community led regeneration approach where communities are supported to take the lead in identifying and implementing local solutions. An example of this is the introduction of the Tipton Development Group which has a membership of forty stakeholders fostering strong partnership and community involvement in the development and delivery of community services. In October 2012, BWA supported by Tipton Development Group, launched its comprehensive community consultation programme which led to the introduction of a 5-year Tipton Communities Connected programme funded by Sandwell MBC and the Big Lottery Fund.



Majority of BWA Limited community services are delivered from its 2 community centres: Tipton Muslim Community Centre and Jubilee Park Community Centre both of which have now been transformed into thriving community hubs and places of welcome providing a variety of high quality community development services to residents of Tipton. BWA advice service each year assists hundreds of Tipton residents with general advice and claim their entitlements to benefits, fuel bills, healthier food, care, mobility and council tax. Positive Activities for Young People is a youth development programme of BWA Limited providing positive activities such as youth club, homework club, and leadership training aimed at improving the quality of life of young people. The Healthy Lifestyle's Programme has been providing multiple integrated health activities promoting benefits of healthy lifestyle. The project is supported by the Big Lottery fund and the Sandwell Council's public health.

Employability Support Programme works closely with SMBC Think Sandwell, Sandwell Consortium and the City Deal Working Together supporting those who are economically inactive and those who are unemployed with job search, interview techniques etc. The Interfaith and Cohesion Programme of BWA Limited promotes education of the community and the contribution that faith and interfaith based activities can make to the promotion of community cohesion. The Families Support Programme engages with local families and delivers activities related to improving their health and wellbeing, creating choices; encouraging social interaction, and ultimately creating a more resilient community in Tipton. Volunteers play an important role at BWA Limited and through the engagement of volunteers, BWA aims to further its reach into the community, facilitating the two-way transfer of skills and knowledge.



ESOL courses provides help to new and old migrants settle into the area Students particularly women learn to read and write English and how to speak it to others. The Come Dine with Neighbours project brings together people of different nationalities to share commonality with food, all showing a keen interest to cook for their Neighbours. Multicultural groups are given a budget to prepare a three-course meal for their neighbours providing an opportunity for multicultural communities to showcase talent in their own cultural cooking. Held annually at

the Victoria Park, Tipton Community Funday brings together over 5000 residents from Tipton for a fantastic, fun-filled day with fairgrounds rides, various cultural food stalls, stage performance and car boot sale, being just a few of the attractions. BWA Limited has been a proud partner in the delivery of the Sandwell Parks Summer Activities and the Let's do Lunch Programme in Tipton. Throughout the school summer holidays, BWA delivers a variety of fun activities for over 300 children and young people at the Jubilee Park Centre.

In The development of sports in Tipton, BWA is committed to promoting the importance of participation in sport and physical activity through delivering a range of sports initiatives such as the Cricket Clubs, and the Sport in Friends Programme. The Tipton Development Group of

BWA was one of just twenty groups selected to participate in a government- sponsored initiative called the Community Economic Development Programme to work with the community to develop the best ideas to strengthen the Tipton economy. A Tipton Community Economic Development Plan has now been produced and endorsed by the Department of Communities and Local Government. BWA Train2Lead Programme has been designed to empower and up skill women as community development champions with possible employment or volunteering opportunities within community sector organisations across Sandwell. In



February 2016 BWA received support from locality to help advocate for neighbourhood planning within the Jubilee neighbourhoods including raising awareness of how neighbourhood planning could help to tackle some of the area's issues. A forum had been established to move forward with the development of a Neighbourhood Plan.

Between 2010 to 2015 the Royal Society of Arts and Manufacturing and its partners at the University of Central Lancashire and the London School of Economics worked with communities in seven locations in England to research & strengthen relationships within communities. BWA supported the research into social networks and well-being in Tipton, and then worked with local-residents to build programmes that support social connections. ODESSA is an international research venture which works with people who are over the traditional retirement age of 60 to find new and innovative ways of adapting a person's home. Tipton was chosen specifically along with Stratford Upon Avon and Norwich as the UK sites for this work. In the delivery of the research in Tipton, Dr Manjit Bola of the University of Central Lancashire works with BWA team to undertake the research work in Tipton.

Working in Partnership with Bangladeshi Regeneration Council & Birmingham Bangla Mela, BWA Limited held an 'Open Air Bangladeshi Community Development Consultation' attracting over 45,000 residents from the West Midlands region. The consultation was designed to enable the community to become creators instead of just consumers of services. BWA Limited also support the Vision 2030 programme - a monthly talk show on SKY 814 which aims to engage and involve the wider Bangladeshi community in England and Wales to move forward with a national regeneration agenda so that by 2030 the Bangladeshi Community should no longer be regarded as a disadvantaged community in the UK.

Bangladeshi Womens Association Limited

The Bangladeshi Women's Association Ltd works in Tipton- a small town with a population of 340,000 located in the Metropolitan Borough of Sandwell. Encountered with multiple deprivation, the association was established in 1985 by a group of enthusiastic South Asian women who wanted to meet the social and economic needs of their disadvantaged peers, young people, and families in Tipton. They started by addressing issues related to social exclusion and lack of community services as well as voicing their ideas for community development.

In the past 32 years, BWA has developed into a community organisation of standing providing a holistic and integrated package of community services to meet the needs of diverse residents in Tipton. In October 2014, BWA launched its five year Tipton Communities Connected programme funded by Sandwell MBC and Big Lottery Fund. Supported by a number of funders BWA currently has 19 active Programmes related to health, education, employment, skills and social inclusion which are delivered from two community centre facilities based in Tipton which are managed by the BWA Limited. According to the BWA client monitoring data, BWA annually provides direct services to an average 3000 residents, deals with 3400 queries and increases household income by an average £300.000 annually.

The Vision of BWA Limited is to work towards an improved quality of life for residents living in Tipton and the wider Borough of Sandwell by providing free access to advice information and training whilst providing central venues for all community groups to get more connected, empowered and confident to have a real stake in the sustainable regeneration of their own neighbourhoods.

BWA Limited is committed to:

- Increasing residents access to high quality Information Advice and Guidance.
- Increasing psychological and physical well-being of women and the elders.
- Increasing communication and strengthening citizenship.
- Increasing skills and learning abilities of residents
- Promoting pride of place and sense of a shared future.


up to talk about the BWA getting the Community Legal Service Quality Mark. She told me how the Bangladeshi women from this part of Tipton had got together to try to improve the area. They had set up school holiday play schemes, organised trips to the sea side and theme parks and some of them were keen to become youth workers. So, the first seeds of community development activity were sown, and in this environment of discussion, debate, listening and talking, the Bangladeshi Women's Association (BWA) developed. In the period 1983 - 1984 the women's group formed and they did achieve the CLS Quality Mark.

By 1985 BWA was ready to become formally constituted. It is significant that the members came from a good cross section of the women, with different ages, backgrounds and lives, and meetings were always bi-lingual so the those who were just starting to learn English could contribute in confidence. Arts and crafts and English classes were also started and this helped to draw in the wider community. From this contact and trust, understanding developed and it soon became obvious that many local people needed help to solve problems with their welfare rights, immigration issues, housing problems, accessing the health service, education and employment opportunities.

In 1989 the BWA Management Committee worked with Sandwell Council to build the Tipton Muslim Community Centre, so that services to meet these identified needs could be established within this community. In 1993, the BWA started to run the Asha project to provide advice and advocacy using the Community Legal Service framework to ensure quality and confidentiality. The Tipton Young Asian Women's Forum was also started to provide education, training and social activities for the young women. The Right Hon Betty Boothroyd came to the centre in 1999, to launch the Bangladeshi Women's Association's Community Capacity Building Project, and in 2002 the BWA supported the TYAWF to deliver a 3year 'Reach' peer education project. These projects quickly 'built capacity' of the organisations and their staff and by 2006 TYAWF gained the Young People's Charter Award (1st in Sandwell) and BWA established its Community Advice Service.

I first met Syeda Khatun when she phoned me The BWA also needed to develop its own organisation - to improve its long-term sustainability and make it able to take on external contracts to increase its income. Neighbourhood Renewal Fund and IT Access points were established. On 5th Jan 2007 BWA was registered as Charity by the Charity Commission. The staff and Management Committee attended a number of training sessions to learn about their roles, the financial management of Charities, the requirements of Child Protection Policies and Procedures and other essentials. In addition, the Management Team increasingly used a strategic planning approach to identify local priorities and potential funding.

> Detailed monitoring systems were introduced, so that evidence of the level of demand and services being delivered could be provided. In 2009, BWA began to offer AIG and training programmes for unemployed people in Tipton. It achieved the Matrix Quality Mark. On 28th May 2012, BWA became incorporated as a Company Limited by Guarantee. This meant that the original Charity registration was closed, but the Company was registered with the Charity Commission on 29 April 2013, as the Bangladeshi Women's Association Ltd, (All the original assets were transferred to this new Charity).



The BWA Ltd. gained a 5-year Service Level Agreement to manage the Sandwell Council owned Tipton Muslim Community Centre. A Microsoft Hub was also established. The Management Committee were also successful in getting a grant from the SITA Trust to do structural improvements and internal decoration. In 2013 BWA Ltd gained a 25-year lease to manage the TMCC, and HTP Enterprise was appointed to improve organisational and programme and development capacity. A few years later they took on the management of the Jubilee Centre, where they have established similar services.

In 2014 a 5-year programme "Tipton Communities Connected" – a community-led regeneration programme involving partnership work was launched. So, throughout the last 30 years, by working closely with, and listening to its local community and finding other like-minded partners and funders, the Bangladeshi Women's Association Ltd. has grown to become a resilient and responsive organisation, even in these challenging times.

BWA Limited Community-led Regeneration approach is defined by actions that are based on the needs and issues understood by and experienced by communities themselves, where communities are supported to take the lead in identifying and implementing local solutions. Our approach is localist - putting residents, community sector organisations and community activists in the driving seat and providing them with hands-on support to drive growth and improve the socioeconomic conditions of Tipton neighbourhoods.

Introduction of Tipton Development Group in 2012, Tipton Communities Connected Programme in 2014 and Tipton Community Economic Development Plan in 2017 are notable examples of community led regeneration in Tipton which aims to

deliver real improvements to people's lives. In the sustainable delivery of these initiatives, BWA is committed to building community, capacity and influence by:

- Developing shared spaces.
- Supporting independent action.
- Encouraging social support networks.
- Undertaking continuous needs analysis.
- Improving local community facilities.
- Supporting local people to come together.
- Building skills and knowledge of residents.
- Untapping, mobilising and building on local assets.
- Building local groups & supporting local governance.
- Engaging communities in decision making processes.

There is no doubt that community led regeneration in Tipton can be achieved through the sustainability of the programmes identified by the community. There is, however, no question that delivering community led regeneration— and rising to all the challenges that stand in the way— will require adequate financial and human-resource capacity and expertise, with adequate local authority support, partnership working and by communities empowered to make well-informed choices.

With the local authority facing a record budget deficit and less money available for investment in community led services, BWA Community Regeneration approach will continue to focus on procurement of external resources as well as creating approaches that involves from 'Asking to Earning' considering opportunities for diversification across the range of available income source needed to ensure that the neighbourhood of Tipton prospers.


SYEDA KHATUN MBE






Programme Aim:

Advice Information & Guidance Service is built on supporting residents in the area, some with little spoken English, and very little understanding of local culture, customs and services. Each year BWA Limited assists hundreds of Tipton residents to claim extra benefits which helps towards regular costs such as fuel bills, healthier food, care, mobility, rent and council tax.

Support Offered:

- A team of multilingual and friendly advice works providing general help dealing with correspondence, translation and interpreting, benefit advice, form filling, welfare benefit advice, and help to access health, education and housing services & other day-to-day problems.
- Signposting and referral support on debt, immigration issues, homelessness, drug dependency and family matters as well as support to secure hardship grants.
- Door knocking in target areas to identify those not accessing help and supporting individuals to identify issues acting as barriers to self-improvement.
- Actively enabling new migrant groups to access community development services.

- Increased financial gains for individuals and families
- Increased self confidence and access to services





Positive Activities for Young People

Programme Aim:

Positive Activities for Young People is a youth development programme based at the Tipton Muslim Community Centre. This programme is jointly run by BWA Limited and Tipton Young Asian Women's Forum and funded by the BBC Children in Need and the Sandwell Council. The services provided by positive activities programme are delivered by qualified staff and is aimed at improving the quality of life of young people.

Support Offered:

- Homework Club: Supported by a qualified Tutors, young people have access to a well-equipped, safe and comfortable and local environment for English and Maths study, homework, revision and access to IT, printing and presentation material at the local one stop shop.
- Advice Club: Supported by qualified Advisor, young people have access to general advice information on entitlements and receive help to produce a Personal Development Plan as a guide to achieve long term academic and career ambitions.
- Youth Club: Supported by qualified Youth Workers, young people participate in planning and benefiting from indoor/outdoor activities, meet other young people, and get support and advice from external service providers including training.
- Volunteering: Young people receive volunteering and work placement opportunities with the centre helping to promote citizenship, life skills, confidence and awareness of opportunities.
- Health Club: Young people have access to weekly structured football and cricket activities. Girls in particular benefit from arts and crafts and healthy cooking sessions.
- Holiday Club: Young people have access to Easter, half term and summer breaks activities involving football, residential, drama, indoor games, and fun educational and social events.
- Leadership Club: Young people benefit from community development, Programme planning, fundraising training & activities towards promoting social responsibility, effective community leadership and sustainable development of their deprived area.



- Increase self-confidence.
- Raise educational attainment.
- Develop a healthy lifestyle.

Programme Aim:

The Healthy Lifestyle Programme has been providing multiple integrated health activities promoting healthy lifestyle choices, in a manner which actively encourages and supports residents to make meaningful changes to their lifestyles through accessing information and activities

Support Offered:

- Health information
- Healthy cooking and eating
- Physical exercise and keep fit
- Understanding mental health
- Health checks for women and elderly
- Health talks on diabetes, cancer, heart disease etc.
- Smoking cessation
- Health coaching
- Walking and jogging

- Increase knowledge of healthy lifestyle
- Improve confidence and self-esteem in healthy living
- Increase engagement in health activities











Employability Support

Programme Aim:

The Employability Programme works closely with SMBC, Think Sandwell and the City Deal Working Together programme primarily targeting those who are economically inactive and those who are unemployed. The programme aims to address the persistent disadvantage experienced by Tipton residents with lower levels of skills, employment and earnings. In the delivery of the programme, a team of Personal Employment Coaches will build a trusting relationship with each individual client engaged and provide 1 to 1 support in a constructive environment that is suitable for them to reach their full employment potential.

Support Offered:

- Diagnosis of the needs of participants and plan Bespoke Training Plans that is developed to record the barriers and support required for individual participants.
- Deliver training service that prepare and provide the adequate skills for participants to secure sustained employment, accredited vocational training, basic skills, Confidence building/mentoring, CV building and interview techniques, Non-accredited training, ESOL and self-employment support.
- Employer engagement and job brokerage.
- Sustained Support to prevent further disengagement.

- Improve self confidence.
- Improve skills for work.
- Improve access to work.



Interfaith and Social Interaction

Programme Aim:

The primary focus of the Interfaith and Cohesion Programme is the education of the community and the contribution that faith and interfaith based activities can make to the promotion of community cohesion. BWA Limited works closely with the Near Neighbours Programme and works to promote potential roles that faith and interfaith can play in promoting community cohesion through faith and interfaith groups as spiritual capital, personal capital, social capital, regenerative capital, as leadership capital, as inter-cultural capital, training capital, youth capital, civic capital and international capital.

Support For Families

Programme Aim:

We know that some of the families in Tipton often have poor outcomes in health, social interaction and educational attainment. The BWA Limited Families in Tipton Programme therefore engages with local families to improve their health and wellbeing, create choices; encourage social interaction, and ultimately a more resilient community. In the process of doing so, the Programme uses a whole family approach. With the child's needs at the centre, all family members needs are identified so that we can include and support all of them. This is essential to helping them build positive relationships in those crucial early years. We also work with our partners such as children centres to make sure families get tailored, wrap-around packages of support.

Skills Based Volunteering

Programme Aim:

ESOL (English for Speakers of Other Languages) courses are aimed at non English speakers. The main aim of ESOL courses is to help people get by in everyday life. Teaching therefore covers everything from how to use public transport, what different ingredients are called in supermarkets to calling emergency services such as Fire, Police and Ambulance.



Come Dine with Neighbours

'Integrating Communities through Cultural Cooking'

Research by Royal Society for the encouragement of Manufactures and Commerce RSA revealed a very important link between feeling close to your community and feeling good about your life. For this reason, RSA offered grants for groups to develop ideas that will bring people together, promote their happiness and help them feel like they can make a difference. 'Come Dine with Neighbours' CDWN was therefore introduced in 2014 as a part of BWA's Tipton Communities Connected TCC programme.

The CDWN project brings together people of different nationalities to share commonality with food, all showing a keen interest to cook for their neighbours. Volunteer Chefs are given a budget to prepare a buffet for their neighbours providing an opportunity to showcase talent in their own cultural cooking; which is often hidden from the wider society.

Previously, all those who participated reported to have felt happy, empowered and confident to have shared with neighbours the ingredients, style and methods of their own cultural food.

Tipton Community Funday

Programme Aim:

Held annually at the Victoria Park, Tipton Community Funday organised by BWA Limited in partnership with Sandwell Council and other partners is a wonderful summer event. Over 5000 residents from Tipton have been coming together for the past 11 years for a fantastic, fun-filled day with fairgrounds rides, various cultural food stalls, bouncy castle, stage performance and car boot sale, being just a few of the attractions. Community and public-sector agencies are also invited to run community consultations, information points and demonstrations for their services.



Summer Play Scheme

Programme Aim:

Throughout the school summer holidays, BWA Limited delivers variety of fun activities for young people at the Jubilee Park Community Centre. On average over 300 children and young people are engaged in positive activities during the summer holidays. In the delivery of the scheme, BWA Limited provides dedicated staff members to: oversee the management of summer activities; liaise with agencies and partners; engage in consultation with the local community; ensure that the necessary Health & Safety, Safeguarding and First Aid arrangements are in place.



The Role of Sport in Regenerating Deprived Areas Report indicates sports development initiatives with the most chance of success achieves a balance between developing sports in the community and the 'development of the community through sports' such as community sports day, cricket clubs, and the sport in friends programme by BWA Limited.

Community Economic Development (CED)

In 2017, we look to a new sustainable development agenda for the people of Tipton, with economic empowerment at its heart. The Tipton Development Group TDG of BWA Limited is rising to that challenge and building upon a history of excellent community involvement and strong partnership working across the three neighbourhoods of Tipton. In 2012, Tipton residents undertook a programme of community consultation working towards improving the lives of communities in Tipton. The process, and the results, have supported the development of a five-year community led regeneration initiative called the Tipton Communities Connected.



In October 2014, work on development of a Tipton Development Plan begun with the acquisition of the Jubilee Park Community Centre which provided a central platform from which Community Consultations were undertaken which engaged with 2430 Tipton residents so far and exposed the stark imbalances in Tipton and recommend solutions to implement.

In 2017, Tipton Development Group was one of just twenty groups selected to participate in the Community Economic Development, or CED, a government- aponsored initiative that provided specialist support, advice and a small amount of grant funding to help communities to work together to develop the best ideas to strengthen the local economy.

The consultation for the CED Programme was undertaken by local residents- with support and training provided them to gain skills as Researchers. The research method included workshops with TDG Members, one to one Interviews and survey questionnaires at community events such as dinner dance, family funday and drop in sessions.

Based on the consultation analysis, Tipton CED Plan was devised and endorsed by DCLG which envisions the creation of centralised community economic hub at Jubilee Park Community Centre. At the hub, residents, businesses and agencies would come together to work for the improvement of Tipton through implementations of the priorities identified in the Tipton CED Plan, such as:

- Creating new jobs in Tipton.
- Getting people into work and improving skills.
- Supporting capacity of local small businesses.
- Supporting local residents to develop enterprises.
- Supporting introduction of creative accial enterprises.
 Bullding employability capacity of community sector.
- Improving local community and sports facilities.

Key to Implementation of the Tipton CED Plan is the appointment of Tipton Economic Development Manager whose primary responsibility will be development and coordination of economic development priorities and programmes identified in the plan



Women's Empowerment - Train2Lead

Programme Aim:

Community or not-for-profit sector is an important yet often misunderstood segment of the economy. Crossing many areas of the economy, it has the potential to generate economic value- employing full-time equivalent of 1.5m staff; engaged with skills and enterprise development; and addressing worklessness, health inequalities, social issues and community cohesion. The sector is also directly linked to a healthy economy with a collective annual turnover of £46bn (ACEVO). Despite the positive outlook, community sector organisations are also facing very different challenges and its future depends on a strong representative voice and a skilled workforce. BWA Train2Lead Programme has therefore been designed to empower and skill up women as community development champions with possible employment or volunteering opportunities with a third sector organisation.

Community Benefits:

Twenty-five learners and five community groups, to date, benefited directly from this Programme. Increased knowledge and understanding of the Community sector indicates the potential for greater benefit through this Programme in the future. The Programme has also generated a large amount of goodwill. Most specifically, we have seen indication of learners:

- Improved confidence to engage in community sector
- Enhanced skills for the development of community sector
- Improved communication and social well-being
- Increased volunteering and involvement in the community
- Creating a pathway for their personal development

Using diversity as a strength

Developing neighbourhood planning in Tipton, in partnership with the Bangladeshi Women's **Association and Tipton Development Group**

Despite the challenges in Tipton, there is a very positive culture of activism and volunteering within the community by a fantastic local charity, BWA - that has a vision to 'create thriving neighbourhoods' in the area.

In February 2016 BWA received a small grant from central government to help them advocate for neighbourhood planning within the community including raising awareness of how it could help to tackle some of the area's issues.

BWA organised a series of community workshops; distributed 200 leaflets door-to-door; and set up a website to help engage local residents, local groups and representatives from local service providers.

By far the most popular session, however, was the local walkabout which energised people into thinking about what they like, what they dislike, and what could be improved or worked on in the area. The walkabout resulted in a smaller area being considered for the neighbourhood plan rather than the Great Bridge ward as was originally envisaged but residents felt that the 'Jubilee Park' area required the greatest investment.



Jubilee Neighbourhood Plan



"Where you live....even the buildings, the houses, it all impacts on people's lives and how they get out of poverty and getting jobs, and that's why we thought this would be a good idea...and it will give people a sense of ownership and pride about the area" PARTICIPANT, BWA Limited.

Their aspiration is to create a neighbourhood where

- affordable and attractive premises for local businesses, and convenient local shops
- greater mix of housing (including social housing) that maintains a mixed community
- green spaces protected for community use
- increased facilities including safe pathways on green space
- better parking
- · more scrutiny of licensing

Next steps - making a plan

BWA are now working with local residents and partners to actively develop a neighbourhood forum, which can lead the process of developing a neighbourhood plan.

Another round of local walkabouts is planned, together with more local consultation activities. In keeping with their assets based approach that recognizes the value of different skills, experience and perspectives, BWA are trying to recruit people that can make the forum effective, as well as reflective of the local area.

They are looking for people that have:

Influence and authority - such as community activists, local authority and public service officers, politicians Insight (into local need) - such as residents, and frontline community workers and service providers

Resources - such as asset managers (the park, community centre, faith buildings), resident volunteers and fund raisers

Expertise - such as specialists in planning and development Information - such as community activists, local residents, local workers and local services





Connected Communities

From 2010-2015 the RSA and its partners at the University of Central Lancashire and the London School of Economics (LSE) was working with communities in seven locations in England (including Tipton) to research & strengthen relationships within communities. The Connected Communities programme explored this vision by surveying residents in ward-sized localities, analysing this data for insight into local social networks and wellbeing, and then working with local people to build Programmes that support social connections such as the Come Dine with Neighbours Programme.



The activities and research presented in the report demonstrate that through working with communities this value can be grown by connecting people to one another in their local areas. The Report argues that investing in interventions which build and strengthen networks of social relationships will generate social value or 'dividend' related to wellbeing, citizenship, economic and capacity shared by people in the community. BWA Limited is working on the implementation of the findings in the report.





ODESSAResearch

ODESSA is a 3 year venture which works with people who are over the traditional retirement age of 60, with a particular focus on the over 80s, to find new and innovative ways of adapting a person's home so that they can live independently for longer and avoid going into residential care as well as making it easier for them to access public services such as health and social services. The Programme is co-funded by UK, France and China.



BWA Limited was asked to represent Tipton people's experiences of the issues that affect them in their homes and local area which in turn will help to influence local and global policy and contribute to the development of an international framework for ageing in place with research partners in France and China. Tipton was chosen specifically along with Stratford Upon Avon and Norwich as the UK sites for this work. In the delivery of the research in Tipton, Dr Manjit Bola of University of Central Lancashire provided a full day training to a group of Tipton resident to undertake the research work.

THE BANGLADESHI REGENERATION COUNCIL ENGLAND & WALES

A disproportionate number of Bangladeshi residents living in England and Wales are experiencing high rates of poverty and deprivation and continues to fare worse on a number of key indicators particularly in employment compared to all others. For far too long the Bangladeshi community has been regarded as one of the most socially and economically disadvantaged ethnic groups in the county. Therefore, to tackle the multiple and generational deprivation within the community, BWA Limited has supported: the introduction of the Bangladeshi Regeneration Council. It is founded on the fact that the Community is a rich source of entrepreneurship and talent and that the community coming together to work on the things that matter to them is a key way of unlocking that resource. BWA also supported an 'Open Air Bangladeshi Community Development Consultation' for the West Midlands region, in partnership with the Birmingham Bangla Mela 2016, giving the community an important voice and an opportunity to influence and enable the people of the Bangladeshi community to become creators instead of just consumers of services.

Vision

"By 2030, the Bangladeshi Community should no longer be regarded as of the most 'socially and economically disadvantaged ethnic groups in England and Wales".

Aim

The overall aim of the Council is to work towards improving the social and economic conditions of the Bangladeshi community living in England and Wales.

Primary Objectives

- Enthuse, engage, and empower the Bangladeshi community and the community sector organisations to be in the driving seat for socioeconomic development.
- ♦ Introduce and implement a series of 'National Networks' focusing on services that addresses deprivation related to Income, Employment, Health, Education, Skills, Training, Services & Civic Society.

BWA Limited is also pleased to support Vision 2030 a monthly talk show on SKY 814 which aims to engage and involve the wider Bangladeshi community to move forward the national Bangladeshi Community Regeneration Agenda.

Governance and Involvment

As a Community Regeneration Organisation, the Bangladeshi Regeneration Council will be governed by an Assembly of 45 Regional Members and a Committee of 10 Directors. We hope that everyone will have a valuable role to play in delivering all aspects of this vital process, and that your involvement will result in prosperous, more sustainable and successful outcome for the Bangladeshi community in England & Wales.
